DIRECTIONS FOR USE

Dilution recommendations using cold tap water:

For Light Soil: 2 oz. per gallon (1:64)

For Moderate Soil: 10 oz. per gallon (1:12)

For Heavy Soil: 16 oz. per gallon. (1:8)

Spray & Wipe Application: Dilute according to the recommendation above. If using this product in a trigger spray bottle, ensure that the bottle is labeled properly. Spray ready-to-use solution onto a microfiber cleaning cloth or paper towel (environmentally preferable). Wipe the surface with the cloth or paper towel to loosen soil. Complete the cleaning by wiping the surface dry using a clean, dry cloth or paper towel.

Spray Application: Dilute according to the recommendation above. If using this product in a trigger spray bottle, ensure that the bottle is labeled properly. Apply diluted product freely to the surface using a coarse spray. Allow dwell time for stubborn grease and soil, agitate if needed. Wipe soil away with a clean dry cloth or paper towel.

Mop/Autoscrubber Application: Dilute according to the recommendation above into a bucket or automatic scrubber. Mop diluted solution onto floor; allow solution to dwell on surface for 5-10 minutes. Agitate solution as required with mop, or with floor machine and pad. Remove solution from floor with mop and bucket or wet-dry vacuum.
