DIRECTIONS FOR USE

Dispense Foaming Degreaser Cleaner Super Concentrate through CLEAN SMART™ Supermarket Dispensing Center. Apply solution through foaming applicator. Allow cleaner to penetrate the soiled surface for 5 minutes and rinse off with a high

pressure spray of hot water. Aluminum surfaces must be rinsed immediately. On food contact surfaces rinse thoroughly with potable water.
