DIRECTIONS FOR USE

Highly Effective, ready to use floor, wall and equipment cleaner for use in all freezer, cold storage and other subfreezer areas to -44°F. AUTOMATIC SCRUBBERS - Equip scrubber with steel wire or other aggressive brushes and fill supply tank with undiluted cleaner. Lay down cleaner solution with scrubbing action. Allow cleaner to remain on surface 5 minutes then using scrubbing action and vacuum pick up, lower squeegee and pick up loosened soil and cleaner residue.

ROTARY FLOOR MACHINE - Equip machine with steel wire or other aggressive brushes. Spray, mop or sprinkle the ready to use

freezer cleaner on the surface to be cleaned. Scrub thoroughly with the floor machine and allow cleaner to remain on the surface 5 minutes. Scrub again, then pick up cleaner and soil with a wetvac or mop.

MANUAL CLEANING - Apply undiluted cleaner by spray, mop or sponge, then aggressively double scrub in the area with a stiff brush or abrasive pad. Pick up loosened soil and cleaner with a wet-vac, mop or sponge. The cleaned surface must always be wet-vacuumed or mopped dry to prevent cleaner residues on the surface. For cold rooms and other temperatures above 0°F the cleaner can be rinsed with water after normal cleaning or diluted 2 parts cleaner with 1 part water for use.
