Add 1/2 oz. of ProLEX PGD-285 to 1 to 2 gallons of water in wash basin or sink. Wash dishes, pots, pans and utensils as usual and wipe or drain dry. For exceptionally greasy ware, a small addition of more ProLEX PGD-285 may be desired.
