DIRECTIONS FOR USE

DISPENSING DIRECTIONS: Attach READY-SET-CLEAN® (RSC) Dispensing Unit to the bottle by threading the unit onto the bottle and tighten securely. Attach water hose to the unit and dispense product by squeezing the flow control handle. Use the locking switch if desired for "hands-free" filling of buckets and automatic scrubbers.

DILUTION DIRECTIONS:

Dispense INCREDILOSO™ solution from the READY-SET-CLEAN® Dispensing Unit at a dilution rate of 1:64 (2 oz per gallon) into a trigger sprayer, bucket or automatic scrubber. Apply cleaner and allow to penetrate grease and soils. If needed, scrub with a stiff bristle brush. Rinse if necessary and allow to dry.
