In low moisture cleaning processes, SOIL FIGHTER PLUS's advanced cleaning performance eliminates the need for rinsing, minimizes carpet downtime and eliminates discoloration problems from wicking. Exclusive anti-re-soiling technology helps carpet resist dirt and soil from becoming entrapped. Carpets become amazingly clean, and remain cleaner longer!

DIRECTIONS FOR USE

SOIL FIGHTER PLUS™ Re-soil Resistant Carpet Pre-Spray Concentrate quickly penetrates and encapsulates greasy, heavy soil for easy removal from the carpet. SOIL FIGHTER PLUS™ is completely safe for stain resistant carpeting as well as all types of carpeting including commercial indoor/outdoor, sculptured, cut or looped pile. It can be used in hotels, motels, schools, offices, airports, hospitals, nursing homes, restaurants or any facility to maintain quality carpeting.

Carpet Pretreatment

- 1) Pretest carpet for colorfastness in an inconspicuous area.

- 2) Remove furniture and dry vacuum thoroughly.
- 3) In a pump-up or pressurized sprayer, dilute SOIL FIGHTER PLUS at a rate of 1:10 (12 oz. per gallon)
- 4) Spray onto carpet or traffic lane.
- 5) Let product set for 10 minutes.
- 6) Extract, bonnet clean or rotary shampoo as required.

NOTE: Due to the variety of carpeting materials this product should be tested at recommended use dilution in an inconspicuous area. Use clean cloth or sponge for application and if test area indicates bleeding, color removal, carpet shrinkage or deterioration of adhesive, do not use.
