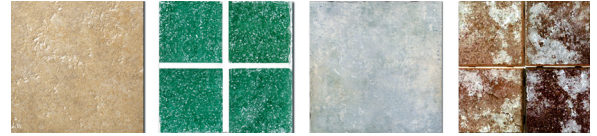




SOIL-LOK™

Penetrating Grout Sealer



DESCRIPTION

Uniquely designed for ceramic tile grouting, this exceptional product repels dirt, oil and water; keeps grout looking bright. A water-based penetrating sealer that repels oil, dirt and moisture from grout. Detergent washable, this product will keep grout looking like new. Does not change the original color of grout. SOIL- LOK allows for vapor transmission to prolong grout life. Can be used indoors or outdoors. Mild odor.

DIRECTIONS FOR USE

Test in an inconspicuous area for suitability prior to application. For new installations, sealer can be applied 48 hours after grouting. Grout joints must be clean, dry and free of existing sealers and coatings. Apply 1 to 2 coats with a soft bristle paint brush or sponge paint applicator. Using cotton or paper towels, remove any sealer remaining on the tile within 3 to 5 minutes of application. If 2 coats are applied, allow a minimum of 30 minutes drying time between coats.

Ready for surface traffic 2 hours after final coat. Sealed area should be kept dry for 12 hours. Achieves a full cure in 24 hours. Conduct a test to determine if surface is completely sealed after 2 hours by applying water droplets to the surface. If water is absorbed, apply an additional coat. Wait 2 hours and repeat the test. Coverage: Approx. 1000 lin. Feet per quart (304m).
