Open the dispenser and remove the empty cartridge. Place a full cartridge into the dispenser, making sure to orient the foaming spout correctly. Once the dispenser is closed, push lever to apply the product to the palm of your hand. Rub hands together working foam over the fronts and back until hands are dry.
