DIRECTIONS FOR USE

Vigor is a highly concentrated extraction cleaner for use in both portable and truck mount extractors. Professionally formulated, it affords exceptionally economical dilutions that lowers costs. Effective for carpets made from nylon, rayon, olefin, wool and other synthetic and natural fibers. Restores carpet to a new level of cleanliness and beauty. Contains no optical brighteners which can damage carpet fibers. Not recommended for use on stain resistant carpeting.

- 1) Pretest carpet for colorfastness in an inconspicuous area.
- 2) Remove furniture and dry vacuum thoroughly.
- Heavily soiled areas such as traffic lanes should be pretreated, spots and/or stains should be treated with COMMAND™ prior to extraction.

- In extractors solution tank mix VIGOR™ according to the dilution recommendations below:
- 5) Extract following manufacturers equipment instructions.
- After the carpet has been cleaned the carpet pile may be brushed in one direction by pile brush.
- 7) Do not walk on carpet until completely dry and then vacuum.
