DIRECTIONS FOR USE

For Cleaning: Sweep floor to remove all loose soil and debris from floor. Dispense LVT Cleaner and Re-Juvenator solution from the DUAL-BLEND® Dispensing Unit at a dilution rate of 1:128 (1 oz. per gallon) into a bucket or automatic scrubber. Use cold tap water only. Please "Wet-Floor / Caution" signs in area. Apply LVT Cleaner and Re-Juvenator solution and allow to penetrate grease and soils. Pick up cleaning solution with mop, automatic scrubber or wet vacuum. Rinsing is not required. Allow to dry thoroughly before allowing foot traffic on floor surface. away from incompatible materials.
